Please read the entire list of instructions below carefully. Incomplete applications or applications with missing information and attachments may not be considered. An independent panel will review applications and select scholarship winners.

1. The DN Community Federal Credit Union (DNCFCU) scholarship is a one-time scholarship to be awarded in May 2022. To be eligible, an applicant must be a graduating high school senior or a student currently attending an accredited college, university, vocational or technical school for the entire upcoming academic year.

Applicant must be an active member of the DNCFCU. DN Community Federal Credit Union employees, board members, committee members and their family members are eligible for scholarship opportunities.

A total of two (2) scholarships in the amount of \$1,000.00 each will be awarded. Submit applications **no later than April 30, 2022** to DN Community Federal Credit Union, ATTN: CEO, 3964 Fulton Drive, Canton, OH 44718.

2. Application and essay must be typed (double-spaced) or legibly printed in blue or black ink.
3. Please complete and submit original application and required attachments in the following order:
 - A. Scholarship Application (2 pages)
 - B. Essay (2 pages maximum)
 - C. One letter of recommendation from school principal, assistant principal, one of your teachers or guidance counselor
 - D. Transcript (official and current)
